## Group Life Insurance

**Death (basic coverage):** the insured sum is paid to the designated beneficiaries.

**Organic losses due to accident:** the corresponding percentage of the contracted insured sum will be paid in accordance with the table and compensation.



**Disability:** the compensation contracted for this coverage will be paid in the event of total and permanent disability.

- 24/7 telephone medical assistance and ambulance.
- Advanced payment for terminal illness of 30% of the contracted insured sum.
